Booking Conditions

1.Contract of hire.

The hiring contract will be between you and John & Susan Warham and will be made subject to these conditions of hire and under English law. The contract of hire does not become effective until you receive written confirmation of the booking from us, We do not accept bookings from hirers under the age of 18.

2.Initial payment.

Bookings will be confirmed upon receipt of the required deposit of £100. However, if a booking is made within 8 weeks of the holiday commencement date, the full rental amount will be required.

3.Balance payment.

The balance of payment is due 8 weeks before the holiday commencement date. The deposit paid on the booking is non-returnable unless the week is re-let.

4.Booking cancellation.

If you are forced to cancel your holiday, please inform us immediately. We will make every effort to re-let the property but you will remain liable for full payment if you cancel within 8 weeks of the holiday commencement date and we are unable to re-let the property.

5.Holiday insurance.

We strongly advise that you arrange holiday insurance for your stay that includes cover for cancellation and your personal property. Your use of the property is entirely at the users' risk and no responsibility can be accepted for injury, or loss or damage to users or visitors belongings.

6.Party numbers.

No more than the maximum number of 4 guests and a baby is allowed to stay in either of the properties. We reserve the right to refuse or revoke any bookings from parties that may, in our opinion, and in our sole discretion, be unsuitable for the property concerned.

7.Hirers responsibilities.

The hirer is responsible for the property and is expected to take all reasonable care of it. All equipment, utensils etc must be left clean and the property is to be left clean and tidy at the end of the hire period.. The property must be vacated by 10.00am prompt on the day of departure to allow cleaning for the next guests. Smoking is not allowed in the premises and it is the hirers responsibility to ensure that smoking does not take place. We cannot accept liability for happenings outside our reasonable control such as breakdown of domestic appliances plumbing, wiring, temporary invasion of pests, damage resulting from exceptional weather conditions or the owners' negligence resulting in loss, injury or accident.
